DuPont<sup>TM</sup> Avaunt® insecticide is recommended as a foliar application to control spotted lanternfly in Grapes, Pears, Pome Fruit, and Stone Fruit. Thorough coverage is essential to achieve control. Multiple applications may be required to maintain control and prevent reinfestation from migrating adults into the crop. Spotted lanternflies are mobile and may reinfest crops quickly. If another treatment is needed before the minimum retreatment interval, use another insecticide to maintain control.

In Grapes, apply Avaunt® at 6.0 ounces/acre (0.11 lb a.i./acre) as a foliar spray based on locally established treatment thresholds. Apply in sufficient water to obtain thorough coverage of foliage. For best results, use an adjuvant to help increase coverage, penetration, and thus performance.

In Pears, apply Avaunt® at 6.0 ounces/acre (0.11 lb a.i./acre) as a foliar spray based on locally established treatment thresholds. Make no more than 3 applications prior to hand-thinning. No hand-thinning after the  $4^{th}$  application. Make no more than 4 applications per season. Do not apply dilute applications of more than 200 gallons of finished spray per acre. For best results, apply 50 - 150 gallons of finished spray per acre.

In Pome Fruit (except Pear), including: Apple, Crabapple, Loquat, Mayhaw, and Quince, apply Avaunt® at 6.0 ounces/acre (0.11 lb a.i./acre) as a foliar spray based on locally established treatment thresholds. Make no more than 3 applications prior to hand-thinning. No hand-thinning after the 4<sup>th</sup> application. Make no more than 4 applications per

season. Do not apply dilute applications of more than 200 gallons of finished spray per acre. For best results, apply 50 – 150 gallons of finished spray per acre, and use an adjuvant.

In Stone Fruit, including: Apricot, Sweet Cherry, Tart Cherry, Nectarine, Peach, Plum, Chickasaw Plum, Damson Plum, Japanese Plum, Plumcot, and Prune, apply Avaunt® at 6.0 ounces/acre (0.11 lb a.i./acre) as a foliar spray based on locally established treatment thresholds. Make no more than 3 applications prior to hand-thinning. No hand-thinning after the  $4^{th}$  application. Make no more than 4 applications per season. Do not apply dilute applications of more than 200 gallons of finished spray per acre. For best results, apply 50-150 gallons of finished spray per acre.

Do not apply more than 24 oz Avaunt® (or 0.44 lb a.i. of indoxacarb containing products) per acre per year.

Do not make applications less than 7 days apart.

Do not apply within 28 days of harvest.

In Pome Fruit (except Pear), including: Apple, Crabapple, Loquat, Mayhaw, and Quince:

Do not apply more than 6.0 oz Avaunt® (0.11 lb a.i.) per acre per application.

Do not apply more than 24 oz Avaunt® (or 0.44 lb a.i. of indoxacarb containing products) per acre per year.

Do not make applications less than 7 days apart.

Do not apply within 14 days of harvest.

In Stone Fruit, including: Apricot, Sweet Cherry, Tart Cherry, Nectarine, Peach, Plum, Chickasaw Plum, Damson Plum, Japanese Plum, Plumcot, and Prune:
