**Application by air**: Apply in a minimum of 10 gallons of finished spray per acre.

# **REMARKS**:

Thorough coverage is essential to achieve control.

Multiple applications (if permitted) may be required to maintain control and prevent reinfestation from migrating adults into the crop. Spotted lanternflies are mobile and may reinfest crops quickly. If another treatment is needed before the minimum retreatment interval, use another insecticide to maintain control.
