#### Reproductive/Developmental Effects

Chlorothalonil: Did not show reproductive toxicity effects in animal experiments. Did not show teratogenic effects in animal experiments.

Oxathiapiprolin: Animal testing showed no reproductive toxicity. Slight delays in maturation observed in rats.

#### Chronic/Subchronic Toxicity Studies

Chlorothalonil: In dogs, 1 year administration caused a significant decrease in body weight gain and increases in absolute liver and kidney weights.

Neurotoxicity: No evidence in regulatory studies.

Oxathiapiprolin: No toxicologically significant effects were found in rat, dog or mouse.
